Code of Ethics

The National Association of Steel Framed Housing Inc (NASH) is a non-profit industry association established for the main purpose of promoting the development of the steel framing manufacturing industry in Australia.

The NASH Constitution includes the following Objective in relation to Conduct:

*“To promote within the steel framing industry **sound and ethical commercial practices** and the maintenance of the highest standards of design and quality of workmanship.”*

It also includes the following Membership Obligation:

*“Members of NASH Inc are expected to maintain **exemplary standards of business conduct** and not act in any way detrimental to the goals of the Association. Members are expected to remain financial within the Association.”*

The purpose of this Code of Ethics is to guide members in the conduct of their business activities by clarifying the meaning of “sound ethical and commercial practices” and “exemplary standards of business conduct.”

NASH members agree to observe sound ethical and commercial practices and to maintain an exemplary standard of business conducting including:

- 1 Abide by the Constitution and Bylaws at all times
- 2 Maintain the confidentiality of Association business where required
- 3 Comply with all relevant laws, regulations, codes and standards
- 4 Work with other members to advance the capabilities and interests of the industry
- 5 Fairly and accurately represent products and services at all times
- 6 Conduct business to reflect favourably on the Association and reinforce public confidence
- 7 Be courteous, helpful, honest and reliable in de Be courteous, helpful, honest and reliable in dealings with enquirers, customers and suppliers
- 8 Use and promote safe manufacturing and construction practices
- 9 Operate at all times within technical and business competence
- 10 Carry appropriate business insurance cover.
